

REGULATIONS FOR FOR USING photoplasticon.com

The present Regulations define rules for using the internet service PHOTOPLASTICON.COM and the rules for acquiring rights to use presented photographs.

ACQUIRING RIGHTS

The photographic material presented on the website is the object of author's and property rights. The photographs can only be used on the basis of the licence document issued by PHOTOPLASTICON s.c., in the scope determined in this document.

MAIN TECHNICAL DISTINGUISHING FEATURES OF THE PRODUCTS

- img.....jpg / resolution 72 dpi / RGB mode (8 bits/channel)
The file can be used in electronic designs in accordance with acquired licence.
- IMG.....TIFF / resolution 300 dpi / CMYK mode (8 bits/channel or 16 bits/channel)
Universal file - for various applications in accordance with acquired licence.

„Path” - means maintained selection that facilitate further processing of the product.
The table under the photo, the column - „yes” - determines hidden selection in product.

All the photographs placed on Photoplasticon.com have a watermark. It is a security feature for protection against non authorised use. After the purchase the photographs are available without watermark.

„WAITING ROOM”

Photoplasticon makes a clipboard called „WAITING ROOM” available.
Chosen photographs preview can be stored there for 60 days.
After this period the files will be deleted automatically.
(The option is available only for logged users)

There is a possibility to download files to one's own resources.

ORDER PROCESSING

1.

A standard order concerns Royalty Free photographs (hereinafter called RF).

These are the photographs that can be used many times, on any territory, on any exploitation field, with restrictions resulting from the licence document. All this only after licence fee has been paid.

2.

In order to have exclusive rights to the photographs a separate licence must be obtained as well as individual pricing must be done.

3.

A separate licence must be obtained and individual conditions of purchase must be set out in case the photographs are used one time.

This option is available exclusively for products with the following technical distinguishing features: IMG.....TIFF / resolution 300 dpi / CMYK mode (8 bits/channel or 16 bits/channel).

4.

Orders are fulfilled after the licence fee has been transferred to the following bank account:

The time of order fulfilment depends on the way it is collected, but it does not exceed 7 working days.

5. The word „materials” means: photographs + licence + invoice.

a - the materials are made available in electronic form, to be downloaded from the website PHOTOPLASTICON.COM. Two attempts can be made each time to download each file.

The photographs may be compressed.

- the materials should be downloaded within 14 days from the date the e-mail with confirmation of possibility to import files have been received (after this period the files will be deleted automatically from Photoplasticon)

In case there are problems with importing „materials” or the above period has been exceeded, please contact our consultant Photoplasticon: PHOTOPLASTICON@PHOTOPLASTICON.COM

b - by „unregistered parcel” at the buyer’s expense to the amount not larger than 1.000 PLN (or the equivalent of the sum in EURO calculated on the basis of the conversion rate on the day of the product purchase).

If the cost exceeds the above sum, it is covered by PHOTOPLASTICON s.c.

c - by courier „unregistered parcel” at the buyer’s expense to the amount not larger than 2.500 PLN (or the equivalent of the sum in EURO calculated on the basis of conversion rate on the day of product purchase).

If the cost exceeds the above sum, it is covered by PHOTOPLASTICON s.c.

Subsection **b** and **c**:

photographs recorded on CD or DVD, printed version of the licence as well as of the invoice.

In case of subsections b and c, the information how the materials are to be delivered should be sent to: PHOTOPLASTICON@PHOTOPLASTICON.COM

The „materials” defined in subsections b and c will be sent within 7 working days counted from the day all the necessary information from the „ordering party - buyer” has been received.

COMPLAINTS

In case the delivered photographs are defective or not in accordance with the description, it is possible to make a complaint within 14 days from the day of delivery.

The complaint shall be considered only if a written statement is issued with the information that all photographs and their copies (in case there were any copies made) have been removed.

The complaint shall be considered within 5 days from the day it was lodged.

After the complaint has been considered the licence for the photographs that are the object of complaint expires.

It is possible to order other photographs in exchange for those that were the object of complaint or ask for the fee to be paid back.

The payment is transferred to the ordering party's account within 7 working days.

FEES

The list of licence fees is presented on the website PHOTOPLASTICON.COM

It is also possible to conclude a permanent cooperation contract and apply separate settling the account, which results in more advantageous purchase conditions.
